CONDITIONS OF STUD SERVICE

- 1. All expenses in connection with the breeding, such as boarding expenses for the bitch, transportation fees, cultures, artificial insemination (consisting of 2 collections), and veterinarian fees incurred in connection with this breeding are the responsibility of the bitch owner and must be paid as they are incurred. The bitch owner will provide required credit card information to the collecting veterinarian and address information of receiving veterinarian for collection services, teaser bitch services, and shipping.
- 2. Stud fee for this dog is \$3000.00. A non-refundable deposit of \$400 is required with the return of signed contract. The balance of \$2600.00 is required in the form of a cashier's check, certified bank check, eTransfer or money order prior to delivery of bitch to Vancouver Australian Labradoodles or prior to shipment or transfer of fresh chilled semen.
- 3. A litter consists of two (2) live puppies at one week of age. If the mating does not produce a litter, one free return is offered to the same bitch and repeat must be completed within 12 months of initial contract. We require progesterone testing for all breedings. No repeat breeding will be provided if bitch owner does not provide progesterone testing for this initial breeding. If breeding occurs via artificial insemination, a repeat consists of 2 collections. The collecting vet will complete a form at the time of collection, detailing the quality of the semen. All costs of these collections and shipments is the responsibility of the bitch owner. Vancouver Australian Labradoodles will not be responsible for any decrease in the quality/quantity of semen as a result of improper handling during the shipping process including inspection by customs agencies in other countries.
- 4. Bitch owner must supply a health certificate from a veterinarian. Health Certificate should specify bitch's good health and condition, and also specify the bitch is free from internal and external parasites, and that her inoculations are current. Bitch owner must also supply a copy of the bitch's OFA/PennHip/ BVA Certificate. Copies must be received by stud dog owner before breeding.
- 5. Stud owner has exclusive rights to sell or keep pick puppy (if in lieu of cash stud fee). If pick puppy is taken in lieu of cash, Vancouver Australian Labradoodles will be the Kennel Prefix of the pick puppy and \$400 deposit will be refunded upon receipt of pick puppy.
- 6. Bitch owner affirms this bitch is either at or over eighteen (18) months of age and has not reached her seventh birthday (7) at the time of this mating. If the bitch is under 18 months of age or over 7 years of age, owner of bitch accepts full responsibility of such breeding.
- 7. Vancouver Australian Labradoodles assumes no responsibility for injury, illness or death associated with the AI procedures performed on bitch by selected veterinarian.
- 8. Bitch owner will not transfer ownership of any pup resulting from this breeding to any person or organization whose intent it is to resell, trade or give away the puppy or use it in laboratory experiments. If bitch owner fails to comply with this provision, he shall pay to the stud dog owner \$5,000.00 in liquidated damages for the harm done to the reputation of the stud dog, the stud dog owner and the breed in general.
- 9. Bitch owner will spay or neuter all puppies, except those retained for future breeding (no more than two), from this litter before they leave for their new homes.
- 10. If the decision is made by the bitch owner to sell or trade intact/entire puppies from this litter, stud owner must approve, in writing, the breeder/recipient of the puppy sold or traded for the intention of future breeding purposes. If the breeder/recipient is approved, stud owner will be apprised of the sales contract between the bitch owner and breeder/recipient of intact puppy, and must approve of such contract in writing.

NO INTACT MALE PUPPIES MAY BE SOLD OR RETIANED FROM THIS LITTER AND A MAXIMUM OF 2 FEMALES CAN BE RETAINED OR SOLD. Approval will not be unreasonably withheld as long as contract is reasonable and at current market pricing.

11. Bitch owner is responsible for the payment of all services related to an on-site Al. Current rate is \$75 per Al.
